Prepayment of Dues

1. Does the membership support allowing States to Prepay dues and to receive a 5% discount against possible future dues increases should one occur?
For example if a state prepays \$1,000 per year in dues for the next three years and in the third year, the membership votes to increase dues to \$1100. The prepaid state would owe an additional \$50 for the third year ($\$1100 - 5\% \text{discount} \text{ or } \$50 = \$1050 - \$1000 \text{ prepaid} = \$50 \text{ owed}$).
