My name is Michael and I am part of the Support team at FreshySites :)

We've gone ahead and added a reCAPTCHA field to your forms.

There are definitely constant scans and several measures in place to prevent brute force attacks and vulnerabilities. That said, one of the best ways to keep vulnerabilities to a minimum is keeping your plugins up to date. As plugins age, security exceptions are often exposed and once known, developers typically release an update quite quickly.

1. We do have various measures in place to safeguard against brute force attacks, security vulnerabilities, malware, and false login attempts. Some of these are at the server-level, and some is via software/plugins installed on the website.
2. We could certainly add a reCAPTCHA to the NASSGAP Contact form, to help weed out spam submissions.

Both of these are something our Support team should be able to answer better, as well as implement any additional adjustments. I'll pass this off to them (CCed here).
